FIXED CARRIER LICENCE TELECOMMUNICATIONS ORDINANCE (Chapter 106)

In accordance with Special Condition 7 of the Fixed Carrier Licence, Hong Kong Cable Television Limited ('HKC') hereby publishes the tariffs under which it will provide the following telecommunication service with effect from 1 January 2007.

Retail Broadband Internet Access Service

I. Introduction

This is a retail broadband Internet access service which conveys Internet Protocol ('IP') based packet transmission between HKC as a broadband Internet service provider and HKC's customers that can be served by this service.

Any notice of termination, to be effective, must be given in the prescribed form and shall not be served earlier than the last two months of the Commitment Period.

² Subscriber who has joined Cable Modem rental program must return the Cable Modem to one of the designated Cable Modem collection centres within 14 days upon the termination of our service. Otherwise \$1,890 will be charged for late return.
